

2025 Commitment Agreement



The Alliance for Innovation in Maternal Health (AIM) is a national, data-driven, maternal safety and quality improvement initiative that relies on the engagement of hospital stakeholders. This quality improvement initiative garners support from healthcare providers dedicated to improving women's health in labor and delivery units.

MI AIM strives to decrease maternal mortality and morbidity in Michigan by working with birthing hospitals to implement the Obstetric Hemorrhage, Severe Hypertension and Maternal Sepsis in pregnancy safety bundles. The purpose of the bundle implementation is aimed at improving health outcomes for mothers by combating the leading causes of preventable maternal mortality. The safety bundles equip hospitals with actionable protocols, necessary equipment, staff education, and staff drills to prevent and adequately treat severe maternal events. Michigan birthing hospitals are at various stages within the bundle implementation spectrum. Success of the MI-AIM efforts are contingent upon partnerships and collaboration of many organizations, including that of the Michigan Health and Hospital Association.

MI AIM is garnering 2025 participation. This document serves as a commitment of this important quality improvement endeavor. The multi-stakeholder team must include an individual from the hospital administration (chief operations officer, chief medical officer, chief nursing officer, etc), an individual from the data submission team, and an individual that works in the OB department and actively engages with the bundle implementation, MI AIM webinars, and Regional Perinatal Quality Improvement Collaboratives.
